<b>Title:</b>	<b>Campus Unplanned Pregnancy Policy</b>

**PURPOSE**

Act 321 of the 2017 Regular Session of the Louisiana Legislature (Act 321) requires that, effective Fall 2018, that each public postsecondary management board along with campus presidents adopt a policy to address the prevention of unplanned pregnancies amount unmarried students as part of freshman orientation activities. Nunez Community College shall strive to ensure that prevention education is shared to all students on [www.nunez.edu](http://www.nunez.edu) but specifically to all new students during orientation.

**SCOPE**

This policy applies to students at Nunez Community College, exclusive of dual enrolled, high school students.

**POLICY**

Act 321 further requires Nunez Community College will provide information to students that is recognized as medically accurate by the American Congress of Obstetricians and Gynecologists regarding the prevention of unplanned pregnancy, including without limitation, abstinence education.

Act 321 prohibits, in all instances, the dissemination of any information regarding abortion methods, techniques, or providers, nor shall any student be directed to information or services provided by Planned Parenthood or any abortion provider.

In addition to the flyer published by the Louisiana Board of Regents in the Fall 2018, Nunez personnel will share the following link with all freshman students which provides information, links and a handout that students may find helpful:
