Act 737 of the 2014 Regular Session of the Louisiana Legislature amended the TOPS Tech Early Start Program to allow the use of the Award:

- At nonpublic postsecondary institutions and training providers recognized by the Louisiana Workforce Commission and approved by BESE, and
- To fund any technical or applied course leading to a certification or certificate in a program approved by the Louisiana Investment Council in a top demand occupation.

On December 9, 2014, the Workforce Investment Council approved the attached TOPS Tech Early Start Eligible Program List. The Eligible Program List includes the 4-digit Classification of Instructional Program (CIP) code for each eligible program. Schools may begin enrolling qualified students in eligible courses beginning with the Spring 2015 semester.

Payment for enrollment in programs that are no longer in top demand occupations (1907 – Human Development, Family Studies, and Related Services; 5204 – Business Operations Support and Assistant Services; 5209 – Hospitality Administration/Management) will be continued for students who were enrolled in these programs prior to Spring 2015. Beginning Spring 2015, Bartending/Bartender (CIP 120502) is no longer an approved program; however, payment will be continued for students who were enrolled in this program prior to Spring 2015.

All 6-digit CIP codes which comprise the 4-digit CIPs, and any pre-requisite course associated with these programs, are eligible for funding with the exception of **Bartending/Bartender (CIP 120502)**. Eligible postsecondary institutions should continue to submit payment request for TOPS Tech Early Start on the

Award System using the 4-digit Classification of Instructional Program (CIP) code for all programs with the exception of those for 1205 – Culinary Arts and Related Services which will require the full 6-digit CIP:
